Chief Watson reported on the following topics:

- **Inspector Competition Results –** Chris Brown-John was identified as the successful candidate.
- Chief's Community Meetings Chief Watson advised of the recent meetings he attended including a presentation for the Abbotsford Downtown Association, Abbotsford Community Corrections, a number of community pop-up events, E-COMM 911 awareness week, prayer breakfast, AbbyPD volunteer appreciation dinner, Fraser Valley Indo Canadian Vaisakhi luncheon, input for JIBC advisory panel, Archway Community Services, and a walkthrough of the new building later this afternoon. He also noted that the SLT did EDI training with Anita Atwal.
- **Police Act Amendment Changes -** Phase 1 of the *Police Act* amendments have been tabled, and there are a number of substantial changes that will result if the legislation passes.
- **Taser 7 Approval –** Recently approved for use by the Province. The Province is looking at the trial and approval of Taser 10 down the road.

Mr. Holloway asked about the Minister's recent announcement about the Surrey Police Service and JI funding implications. Chief Watson advised there is still no resolution although another meeting has been called for mid-May to discuss this again.

#### 6. Standing Board Committee Reports

- a. **Finance Committee** Mr. Holloway noted that budgets & reporting are becoming more important.

- c. **HR Committee** Nothing to report.

#### 7. Other Business
