The meeting was called to order at 8:49 AM.

1. Adoption of Agenda

It was moved and seconded that the Agenda be **approved**. The motion was **adopted**.

2. Presentation – AbbyPD Traffic Enforcement Unit

Sgt. Paul Walker presented on the AbbyPD Traffic Enforcement Unit.

Discussion on data retrieved from impaired drivers and comparison of drivers being impaired by alcohol or other drugs. It was advised that alcohol impairment is seen more often than drug impairment, but that there is ongoing training for frontline staff for drug impairment recognition. There are expectations that we will see drug impairment increase once more members are trained. Sgt. Walker also advised that new recruits receive drug impairment recognition training just after graduation, hoping that the JIBC will add the training to the curriculum. 4 members are trained in drug impairment recognition at the highest level. Given the limited seat availability at the JI for training, those members are becoming instructors, so we can conduct our in-house training so members can be trained quickly.

The AbbyPD is seeing an increase in impaired incidents from year to year. It was advised that the Patrol's downtime to find impaired drivers is decreased due to workload and that the TEU's numbers are higher given their mandate for traffic safety. It was also advised that provincial funding received for targeting impaired driving has decreased over the years, so there aren't as many officers or approved overtime.

Action: Chief Watson will work with Sgt. Walker to obtain the impaired driving data (alcohol compared to drug use) and provide same to the board.

Discussion on the officer's time at traffic court taking away resources on the road, with 30% of tickets being disputed (estimate). It was advised that collaboration between the police departments and the courts was unsuccessful. Sgt. Walker recently made a motion to remove ticketing from Provincial Courts and to adjudication as a cost and time-saving measure. There is a strong desire within the department for officers to be on the road and not in court.

Sgt. Walker exited the meeting.
